

On the subject noted above, the Sub Divisional Engineer, Provincial Sub Division No-2, PWD B&R Br., Beri has reported that he has inspected the Building of G.S.S.S. Beri alongwith concerned J.E and the teaching staff of this School on dated 05.07.2023. The class rooms, offices, labs were inspected visually. Main office of School and old class rooms, labs have no cracks on walls, windows are in good condition. R.C.C. slabs ceiling have smooth surface. Bottom plaster of first floor veranda above main office is cracked and steal of the beam is exposed from bottom at two/three locations.

The bottom plaster of slab of main staff room indicated as room no. 13 has damaged and steel is exposed. The level of school building is down as compared to adjoining road level. Photographs of the same are attached herewith.
